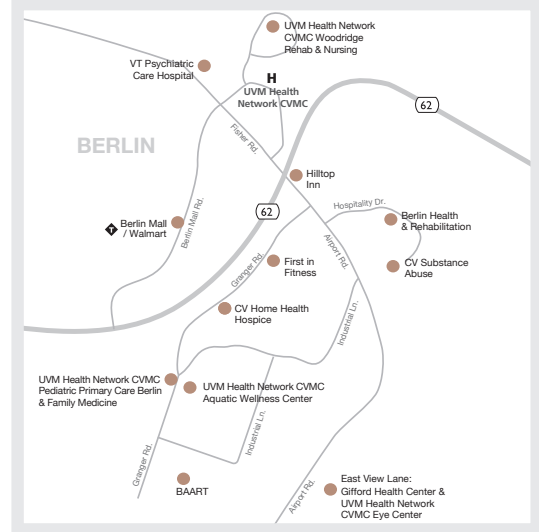


## Granger Road Vicinity
