# **Approval of Committee Minutes**

Commissioner Waninger went on to say that the Vice Chair position is still unoccupied. Commissioner Kaynor indicated that it is the charge of the Leadership Committee to nominate candidates. Commissioner Sharrow proposed that Commissioner Kaynor serve as temporary Vice-Chair.

Commissioner Waninger will reach out to current member to inquire about interest and possible nominees. Elections will be held in July and will take place at the July Board meeting.

Mr. Moore will add nominations to the July Leadership meeting.

# General Manager Updates

Mr. Moore gave the following updates:

- COVID-19 Response Ridership has increased, stating that there have been some challenge with onboard limits.
- Covering Policy Implemented face-covering has been difficult to implement, but stated that GMT has no exemptions/exceptions to this policy, and that all passengers over the age of 2 must wear a mask to board a bus.
- Combined Time Off (CTO) Policy GMT staff has begun developing an internal plan.
   However, it is not likely to have a staff recommendation for next week's board meeting.
   Mr. Moore recommends that we hold off to January 1, 2021 (September board approval) before implementing a new policy.
