## Transit Strategic Plan (TSP) Overview and Timeline Discussion

General Manager Moore gave a brief update of the agenda and format of the retreat. Director Smith gave an overview of the Transit Strategic Plan, including the five chapters and the timeline of the project. Chair Waninger asked if this is an urban/rural project, Director Smith confirmed that it is both urban and rural focused.

Director Smith reviewed the draft vision statement and core values for GMT and asked for feedback from Board members. General Manager Moore added that the vision and core values will be the guiding language for the TSP.

Commissioner Wallis asked that staff consider adding references to energy efficiency and diversity and inclusion into the draft vision statement and core values. Commissioner Kaynor asked to include sustainability and energy transformation.

## **Review of Draft FY22 Strategic Goals**

General Manager Moore provided an overview of the Strategic Goals. Commissioner Baker asked about innovation and where that falls within the strategic goals. General Manager Moore said that innovation is a concept that affects several goals in the document.

Commissioner Derenthal asked if GMT needs to consider the bandwidth of the organization. General Manager Moore responded not necessarily. The TSP will include concepts that are 10years into the future without a full understanding of the resources needed to complete them.

Commissioner Waninger stated that she thought cost effectiveness was a subset of Financial Stewardship and asked that goals 3 and 4 could be merged.

Commissioner Polyte stated that there were a lot of redundancies and the breakout will help us see where the similarities are. Commissioner Baker added in the comments under respect: should be: placing a high value on diversity and inclusion.

General Manager Moore went through the structure of the goals.

Commissioner Waninger asked if staff think tactics are the step-by-step process or the major steps.

Commissioner Pouech asked if we should be discussing KPI and maybe staff should be checking if the data is readily available.

General Manager Moore said the KPIs will track the metrics and gives staff the ability to report out on progress.
